Sixteenth Judicial Circuit: On January 16, 1836, a new County was formed and named after Elias Kent Kane, a highly-respected attorney who helped draft the Illinois constitution and was the first Secretary of State. Kane was later elected to Congress and represented Illinois in the U.S. Senate. On the night of March 13, 1890, Kane County lost one of its most prized buildings when the Courthouse burned.
